

SUPER 48K GIVEAWAY PRESENTED BY h.h.gregg AND SAMSUNG

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **PROMOTION DESCRIPTION:** The **Super 48K Giveaway presented by h.h. gregg and Samsung** (the "Promotion") is an online Daily Sweepstakes (the "Daily Sweepstakes"); Weekly Sweepstakes ("Weekly Sweepstakes") and Grand Prize Sweepstakes (the "Grand Prize Sweepstakes"). The Promotion begins on 1/5/14 at 12:00:00 AM (ET) and ends on 1/28/14 at 11:59:59 PM (ET) ("Promotion Period"). There will be one (1) Daily Sweepstakes winner for each Day of the Promotion Period to be determined by random drawing from among all eligible entries received for each Day. A "Day" is defined as a consecutive twenty-four (24) hour time period during the Promotion beginning at 12:00:00 AM (ET) and ending at 11:59:59 PM (ET). There will be three (3) Weekly Sweepstakes winners for each Week of the Promotion Period to be determined by random drawing from among all eligible entries received for each Week. A "Week" is defined as a consecutive seven (7) Day period during the Promotion Period starting on a Wednesday and ending on a Tuesday. There will be one (1) Grand Prize Sweepstakes winner for the Promotion to be determined by random drawing from among all eligible entries received during the Promotion Period.
2. **HOW TO ENTER THE DAILY SWEEPSTAKES:**
 - A. **Promotion Website Entry.** You may enter the Daily Sweepstakes at the Sponsor's promotion Website by going to <http://www.hhgregg.com/Super48K> ("Website"); and then follow the instructions provided to complete your entry. Limit one (1) Website entry per person/email address, per Day.

 - C. **Mobile Online Entry.** To enter the Daily Sweepstakes at the Mobile Website using your web-enabled mobile device, go to www.hhgregg.com/Super48K; and

then follow the instructions provided to play the Game. Limit one (1) Mobile online entry per person/email address, per Day.

- D. Game Play Entry. You may enter the Daily Sweepstakes by playing the Endless Blitz game (“Game Play”) via a mobile application; and/or at the game website. You may earn up to three (3) entries per Day via the Game Play method of entry. In order to earn an entry via the Game Play method of entry, you must achieve the following number of yards by playing the Endless Blitz game to receive the specified number of entries: achieve 100-yards = 1 Sweepstakes entry; achieve 300-yards = 2 Sweepstakes entries; achieve 600-yards = 3 Sweepstakes entries. Maximum of six (6) Weekly Sweepstakes and six (6) Grand Prize Sweepstakes entries per person/email

address, per Day (one (1) via Promotion Website method of entry; one (1) via Facebook method of entry; one (1) via Mobile Online method of entry; and three (3) via Game Play method of entry).
